## **Board of VDMA Photovoltaics Equipment confirmed**

**Frankfurt, December 10, 2024** – The VDMA's Photovoltaic Equipment sector group held its regular elections at its board meeting on December 5 and confirmed its top management. Prof. Dr. Peter Fath, RCT Solutions GmbH, was re-elected as Chairperson of the Board and Dr. Stefan Rinck, Singulus Technologies AG, was re-elected as Deputy Chairperson.
